Dear Parents/Guardians,

Your 6th, 7th, or 8th grade son/daughter has earned the opportunity to participate in a ski, snowboarding, and tubing trip on Friday, February 9th from 8:10 am to 3:10 pm at Christmas Mountain near Wisconsin Dells.

Students will be eligible to attend the ski trip if they have:

- 3 or less missing assignments for Term 4
- Are on Step 0 (no Major Discipline Referrals), Step 1, or Step 2. Students on a Step 3 or higher will work out a contract with Mr. Becker to show that their behavior is improving.

The cost of the trip for your student is \$10. Students can participate in any activity they would like: skiing, snowboarding, or tubing. They do not have to choose ahead of time, just prepare for being outside, to participate, and to have fun! **Students may not bring their own equipment.**

Your child may bring their own lunch from home, bring money for lunch, or have a sack lunch provided through the school lunch program (**charged to your student's lunch account**). A sack lunch through the school lunch program includes a sandwich, chips, milk, fruit, and a fruit or grain bar so please send water or other drinks with your child that day. Students may also purchase drinks and snacks at the ski hill.

**Permission slips, Release of Liability form and money must be returned to school no later than 3:00 pm on Friday, February 2nd.** If your child wishes to attend the trip but does not want to participate in the activities, they must still turn in the signed permission slip by the due date.
