Despite our efforts to be responsive to community members and actively cut costs, the Necedah Area School District faces a number of financial challenges in the coming years and recognizes that further reductions to balance the budget would increasingly impact the quality of education we provide our children.

- Last spring, the board presented voters with an operational referendum to exceed the district's revenue limit authority by approximately \$800,000 on an ongoing or recurring basis. This referendum question was narrowly voted down. As a result, the district had to move forward with program reductions and deferred operational expenditures.
- Feedback from a November 2017 community survey reflected strong support for a non-recurring referendum of up to a \$13.33/month tax increase for every \$100,000 of assessed property value.
- The board's proposed referendum has a maximum tax impact of \$12/month, which is less than the level community members indicated they would support in the survey.
- If passed, the referendum would allow the district to exceed its revenue limit for four years and four years only. The non-recurring step solution would break down to \$690,000 in years 1-2 and \$750,000 in years 3-4.
